- ☐ Employee Share Schemes
- ☐ Partnership + Trust Distributions
- ☐ Business (ABN) Income (inc details of GST regn)
- ☐ Income from Uber Driving, AirTasker etc
- ☐ Foreign Income / Foreign Pensions
- ☐ Rental Property (or AirBnb) Income
- □ Backpay (or lump sum payments in arrears letter)
- ☐ Crypto tax report (essential if you hold this type of investment)
